AI-CONNECTX PRIVACY POLICY

This privacy policy("Policy") describes how AI-ConnectX. ("AI-ConnectX") collects, uses and shares the personal information of consumer users of AI-ConnectX's products and services. This Policy also applies to all of our other offers that refer to this Policy.

WHAT AI-CONNECTX COLLECT

Al-ConnectX may collect both personally identifiable and non-personally identifiable information from you (collectively, "your information") through Al-ConnectX's products and services. Personally identifiable information is information that identifies (whether directly or indirectly) a particular individual, such as your name, postal address, email address and telephone number. Non-personally identifiable information is information that does not directly or indirectly identifies you, and cannot reasonably be used to identify you. When non-personally identifiable information is directly or indirectly associated with personally identifiable information, this non-personally identifiable information may also be treated as personally identifiable information. - **Information You Give Us**. Al-ConnectX collects your name, email address and any other information you give us on our Site.
- **Information Al-ConnectX Get Elsewhere**. Al-ConnectX may get information about you from other sources, such as other agreements.
- Information Automatically Collected. AI-ConnectX may automatically log information about you. For example, when visiting our Site, AI-ConnectX logs the pages you view, how long you spend on a page, access times and information about your use of our Site and actions you take on our Site. This type of information is collected to improve the Site and make it more useful to you.
- Cookies. AI-ConnectX may log information about you using "cookies." Cookies are small data
 files stored on your hard drive by a AI-ConnectX site. AI-ConnectX may use both temporary
 cookies (which expire once you close your AI-ConnectX browser) and persistent cookies (which
 stay on your computer until you delete them).

HOW AI-CONNECTX USES YOUR INFORMATION

AI-ConnectX may use your information as follows:

- To operate, maintain, and improve our Site, products, and services;
- To respond to comments and questions and provide customer service; and
- To provide and deliver products and services customers request.

Al-ConnectX stores your personal information in our cookies and Al-ConnectX uses those cookies to track and keep information about your movement from page to page within the Site.

Al-ConnectX will only keep your personally identifiable information for five (5) years, after which time your personally identifiable information will be deleted from our records.

SHARING OF YOUR INFORMATION

Al-ConnectX will not share or sell your personally identifiable information with other parties, except:

- When AI-ConnectX does a business deal, or negotiates a business deal, involving the sale or transfer of all or a part of our business or assets. These deals may include any merger, financing, acquisition, or bankruptcy transaction or proceeding;
- To detect, investigate and prevent activities that may violate AI-ConnectX's policies or be illegal;
- When AI-ConnectX decides in our sole discretion that AI-ConnectX needs to for legal, protection, and safety purposes, including:
 - To comply with laws;
 - o To respond to lawful requests and legal processes;
 - To protect the rights and property of Al-ConnectX, our agents, customers, and others.
 This includes enforcing our agreements, policies, and Terms and Conditions; and
 - In an emergency. This includes protecting the safety of our employees and agents, our customers, or any person; and
- When AI-ConnectX decides in our sole discretion that AI-ConnectX need to share information with one of our employees or agents who needs it to do work for us.

Al-ConnectX may share non-personally identifiable information with others.

PROTECTION OF YOUR INFORMATION—SECURITY MEASURES

Al-ConnectX stores your password information on our servers in encrypted form using AES256 bit encryption. Al-ConnectX do not employ any other technological measures to secure your personal information. Al-ConnectX use reasonable commercial efforts to restrict access to your personal information to our employees, contractors, and agents, for whom the information is necessary to respond to you and provide, maintain and improve the Site.

THIRD PARTY SITES

Our Site may provide links to third-party Al-ConnectX sites for your convenience and information. If you access those links, you will leave our Site. Al-ConnectX do not control those sites or the privacy practices of their operators, which may differ from ours. Al-ConnectX do not endorse or make any representations about third party Al-ConnectX sites. The information you choose to give to unrelated third parties is not covered by this Policy and Al-ConnectX have no responsibility to you with regard to your use of those third party Al-ConnectX sites. YOUR CONTROLS
